Resolution with Regard to 3124 Corporation t/a Good Guys, ABRA Licensee #899

On behalf of ANC3B, Commissioner Blumenthal introduced the following Resolution:

Whereas, at the June 11, 2009 meeting of ANC3B, the Commission approved a request from 3124 Corporation (hereafter “Good Guys”) to alter the requirement in its Voluntary Agreement (section 3(a); VA approved 12/22/2007) to temporarily change the requirement regarding the presence of security personnel from a start time of 7 p.m. at the front door to 9 p.m., and from 9 p.m. at the back door until 10 p.m., on a trial basis from June 11, 2009 until October 12, 2009;

Whereas, when the trial period expired on October 12, 2009, no action was taken by either party to the temporary agreement;

Whereas, on April 9, 2010, at approximately 6:30 p.m. a fight occurred on the sidewalk in front of Good Guys involving four patrons of Good Guys in full view of members of the Glover Park community and other pedestrians going to and from the stores and playground at this busy time of day;

Whereas, according to the police report of the incident, the fight was violent enough to require hospital treatment for two of the four men involved and those two were arrested and charged in this incident, which included an allegation of the existence of a knife;

Whereas, ANC3B represents the interests of the community in maintaining a peaceful, safe environment for all those who live in Glover Park and who patronize our stores, restaurants, and other establishments;

Be it resolved, that ANC3B not only formally terminates the temporary change in security personnel hours that was due to expire last October, but also requests that Good Guys agree to amend the first sentence of Section 3(a) of Good Guys’ Voluntary Agreement as follows:

“From 5 p.m. to closing each day the establishment shall employ a security person who will be permanently stationed at the front door of the premises.”
