Discussion Regarding Liquor License Application by Trader Joe's

Perry Zettersten, Regional Vice President of Trader Joe's, will discuss plans for the market to open in the development at the old Holiday Inn site and request ANC support for a Class B (retail, beer and wine only) liquor license. The ANC will open a public comment period to hear from the community and will act on the request for support at its November 2 meeting.

Decision Regarding Zoning Application for Domino's at 2330 Wisconsin Avenue NW

At the ANC3B September meeting, Domino's explained plans for an eat-in, carry-out and delivery operation in half the space left vacant when the El Salvadoran Consulate moved. All fast-food operations applying to open in the Glover Park commercial district require a special exception from the DC Board of Zoning Adjustment, which looks for comments from the community in making its decision.

Resolutions Regarding Pedestrian/Vehicle Safety at W Place, Fulton Street, and Davis Place

The ANC will take up three resolutions asking DDOT to take steps to improve safety:

- to address traffic speed and parking congestion at the intersection of W Place and Wisconsin Avenue
- to investigate pedestrian safety at the intersection of Davis Place and Tunlaw Road
- to formalize a previous request to DDOT to remove two parking spots on southbound Wisconsin Avenue north of Fulton Street to improve sight-lines for anyone approaching Wisconsin Avenue from the west
