Emanuel Briggs, DC Water

Greer Gillis, Deputy Director, District Department of Transportation (DDOT)

Discussion about pedestrian safety improvements in the wake of the pedestrian fatality at Calvert and 37th Streets, as well as pending and potential DDOT-related issues (postponed from July meeting).

Resolution In Favor of Lifting AM Rush Hour Parking Restrictions on Northbound Wisconsin Avenue

Restrictions were added when the number of lanes on Wisconsin Avenue was reduced from 6 to 4 through Glover Park. Now that all 6 lanes have been restored, businesses are seeking restoration of the morning parking their patrons used to have on the northbound (east) side of Wisconsin Avenue.

Resolution Regarding Request for Curb Cut at 3814 Fulton Street

ANC comments are due September 16. The developer has been invited to the meeting. He proposes to raze the home at 3814 Fulton and build a new house with double garage entered from the front/street.

Resolution Regarding WMATA's Proposed Cuts on D1 and N3 Bus Routes

The ANC will weigh in on the proposal to eliminate the N3 line, the last D1 bus of the day (7:05 pm) to Glover Park, and D1 service between Franklin Square and Federal Triangle.

Resolution Regarding New Airplane Routes to National Airport

A recent shift in flight paths over NW Washington has brought increased disruption to neighborhoods from Foggy Bottom to Palisades. ANC3B has been asked to support the efforts of a group of local community organizations to get the FAA to review its decision allowing the new routings.

Grant Request from Iona Senior Services

Iona is asking for \$2,500 to help defray the cost of printing its newest comprehensive Resource Guide.
