#### **Resolution RE Proposed Settlement Agreement in PSC Case over Sale of Pepco to Exelon**

After the DC Public Service Commission (PSC) decision in August to reject the proposed acquisition of local electric utility Pepco by Exelon Corporation of Chicago, Exelon and Pepco negotiated a settlement with some of the parties, which is now open for comment. The settlement includes some additional benefits for the city and its ratepayers but does not resolve all the concerns expressed by the PSC and is still opposed by numerous consumer, energy and environmental groups in the District as not in the long-term public interest. ANC3B has been closely tracking the proposals and consistently expressed concerns that the commitments by Pepco and Exelon are not sufficient to overcome the risks of the transaction for residents and the city in the long run. Comments are due to the PSC on December 23 (extended from original due date of December 18.) The ANC invites public input and plans to adopt a resolution on the settlement agreement at the meeting.

#### **Discussion and Potential Resolution Regarding Entertainment Endorsement for Arcuri**

Arcuri restaurant (2400 Wisconsin Avenue, below ground) has applied to the Alcoholic Beverage Regulation Administration (ABRA) for permission to offer live entertainment. The deadline for community comment is January 11, which is before our next meeting. Adam Hildebeitel from Arcuri will present the restaurant's plans for entertainment. The ANC will vote on whether or not to protest Arcuri's application for permission to provide live entertainment.
