The soon-to-open Rite Aid (across the street from CVS where the hardware store used to be) wants to sell beer, wine and spirits but the Glover Park Moratorium does not allow new full-service, retail liquor licenses. The ANC is being asked to amend its petition to ABRA regarding the renewal of the moratorium, which expires February 21, to lift the restriction against more Class A, full-service, retail liquor licenses.
