Police Report

Greer Gillis, Deputy Director, District Department of Transportation (DDOT)

Discussion about pedestrian safety improvements in the wake of the pedestrian fatality at Calvert and 37th Streets, as well as pending and potential DDOT-related issues.

Resolution Regarding a Bike Route on Tunlaw and 37th Streets

The planned route is an extension of the bike route on New Mexico Avenue that will eventually connect into Georgetown. For most of its path through Glover Park it will consist of share-the-road signage; a dedicated bike lane is proposed only for the uphill stretch on southbound Tunlaw Road between 39th Street and Davis.

Resolution Regarding DDOT's Proposed Regulations Governing Electronic Signs

This proposal gives the Mayor the sole authority to create Designated Entertainment Areas, which would be allowed to have electronic signs and billboards, without any provision for hearings, public comment or the usual opportunities for ANC participation.

Resolution Regarding the Intersection of Garfield Street and Wisconsin Avenue

Confusing lane markings are creating a dangerous situation for drivers. The markings are left over from the failed attempt to calm traffic on Wisconsin by reducing the number of lanes. DDOT should assess the intersection and determine how best to make it safer.

Resolution Regarding Proposed Savoy Suites/Kimpton Hotel Roof Deck Plans

Due to liquor license application timing and the fact that ANC3B does not meet in August, we are forced to consider taking action in order to keep negotiations open regarding hours and entertainment proposed for the roof of the hotel. We hope an agreement can be reached between the hotel and its neighbors before any formal protest goes forward.
