**Police Report**

Request re preventing K-turns in front of Stoddert School in morning drop-off and afternoon pick-up times.

**Office of Unified Communications**

Karima Holmes, Director, will present an overview of her agency, which manages DC's 911 emergency call system, and what has been done to prevent another temporary failure such as occurred in the summer.

**Rent Control Issue**

ANC3F02 Commissioner Shirley Adelstein will speak on rent control issues, particularly about concessions that can financially penalize tenants. The DC Council is taking up four separate bills focused on rent control issues this fall. ANC3B may vote on a resolution regarding rent control legislation in November.

**Security Cameras Surrounding Russian Embassy Compound**

Cliff Seagroves of the State Department's Office of Foreign Missions will explain the new security cameras along Tunlaw Road, Fulton, and Calvert Streets.

**Grant Request from Hardy Parent Teacher Organization (PTO)**

Jane Alexander will present the PTO's request for \$2,500 to enhance the materials in the school library.

**Public Space Application Re Holiday Inn Site Development**

The ANC proposes to vote "no objections" to the application covering landscaping and paving surrounding the development site. Developers will present their plans in detail at the ANC's November meeting.

**Resolution Regarding the Draft Statehood Constitution**

ANC3B will consider a resolution requesting amendments to the draft Constitution that will be considered by the DC Council as part of the campaign for statehood. (A separate initiative is on the November ballot.)

**Good Guys Settlement Agreement**

ANC3B will vote on an agreement with Good Guys to update and condense the terms of all the agreements since 1999. The new agreement will permit Good Guys to renew its license for three years without protest.

**Resolution Regarding Restoring or Replacing Fillmore Arts Center Programming**

The ANC will ask the Mayor to ensure that Stoddert and other school children continue to have access to a full range of arts programming with or without access to Fillmore.
