**Discussion on the "Second Look Amendment Act of 2019" (B23-0127)**

The bill would give judges authority to release an individual from prison after she or he has served at least 15 years, if the individual was younger than 25 when the crime was committed.

**Grant Request from Iona Senior Services to buy laptop for classes/workshops**

Jennie Smith-Peers, Iona's Director of Development, will present request for funds for a laptop to be used in conference room for staff training and classes/workshops open to the public.

**Presentation by DC Office of Campaign Finance (OCF) on new public financing program**

OCF will speak about the District's new Fair Elections/Public Finance Program, which provides start-up funds and 5:1 match for donations to a candidate running for city office (other than ANC Commissioner) if the candidate agrees to accept only small individual campaign contributions.

**Presentation by DC Water on its new assistance program for Lead Line Replacement**

John Deignan will speak about funds available to help low income families cover the cost of replacing lead water lines on their property. DC Water pays to replace lead lines in public space.
