**Presentation on Iona Senior Services plans and programs for the Ward 3 community**

Iona Community Outreach Coordinator Pleasance Silicki will provide information on their current and planned activities and services for seniors, caregivers, and others. Iona has two locations: one in Tenleytown and one in Congress Heights. The Tenleytown location is on Albemarle Street just west of the Tenleytown Metro station. Iona is the non-profit organization designated by the District Department of Aging and Community Living as the lead agency for Ward 3 and provides services such as information on nutrition, health and care options, as well as consultation and referrals to needed services for older adults and caregivers of older adults. Iona provides a wide range of opportunities including recreational and active wellness programs, support groups, in-home peer support, help with navigating dementia, seminars on topics such as health and nutrition, cultural and arts programs, support for caregivers, and advocacy for seniors. Iona’s social workers, nurses and other staff also offer adult day health programs at each of its locations, as well as counseling and care management. Most of Iona’s programs and services are free and available to DC residents age 60+ or caregivers of individuals 60+.
