**Vote on request from Laliguras for an entertainment endorsement and full hours for alcohol service**

Laliguras has applied to ABRA for permission to offer karaoke entertainment in its establishment at 2232 Wisconsin Avenue and to increase its hours of alcohol service to the maximum allowed. The ANC hopes to vote on mutually agreeable terms to allow entertainment and the same hours as other licensees in Glover Park.

**Letter of Support for Clean Decisions, provider of the Clean Team on the Wisconsin Avenue commercial strip**

Will Avila of Clean Decisions was invited to make a presentation about their work as the Clean Team for Glover Park. Clean Decisions is seeking support for their application for a grant from DC Department of Small and Local Business Development (DSLBD) to continue serving our community as the Clean Team in the coming year.

**Letter to DDOT on Proposals for Bike Lanes on New Mexico/Tunlaw/37th Street Corridor**

DDOT representatives made a presentation at the ANC3B meeting in July as part of Community Engagement over a potential DDOT project to improve safety for bicyclists and other users of the corridor from Nebraska Avenue to Reservoir Road, including through ANC3B as well as neighboring ANC3D in Wesley Heights and ANC2E in Burleith. DDOT outlined several alternatives they had reviewed over recent months. DDOT has been reviewing comments submitted by residents about the various alternatives, but indicates it will not be prepared to present any new information or designs to ANC3B until October. The Commissioners plan to present a summary of public comments and priorities and articulate principles DDOT could consider in identifying its primary options to present to the community, before a formal Notice of Intent and Public Comment Period.
