**Resolution to Amend the Settlement Agreement Affecting the Operation  
of a Class CR Liquor License at 2218 Wisconsin Avenue NW**

Whereas, Wingos 3 LLC trading as Wingos ("Wingos") is licensed by the Alcoholic Beverage Regulation Administration ("ABRA") to serve beer, wine, and spirits in a restaurant setting at 2218 Wisconsin Avenue NW under ABRA Lic. #108985;

Whereas, in 2008, 2015 and 2019, ANC3B and the then-licensee at the location entered into an agreement and subsequent amendments to settle or avert protests against the then-licensees, which set site-specific conditions on the operation of a liquor license at that location;

Whereas, the 2008 Settlement Agreement was approved by the Alcoholic Beverage Control Board ("the Board"), which ordered the agreed-upon conditions to apply to any subsequent ABRA licenses at that location;

Whereas, the current licensee at 2218 Wisconsin Avenue, Wingos, has petitioned the Board to amend its settlement agreement to remove restrictions on its entertainment endorsement so that it can offer live music, karaoke events, poetry readings and other similar events;

Whereas, the Commissioner for ANC3B-02, the residential area which abuts the property at 2218 Wisconsin Avenue, has consulted with near neighbors who have expressed concerns about hours of entertainment, noise control, and responsiveness to complaints;

Therefore, BE IT RESOLVED that ANC3B will agree to amend the standing agreement with the following provisions:

1. ANC3B agrees that Wingos shall be free to use its entertainment endorsement for live music, karaoke events, poetry readings and other similar activities governed by the entertainment endorsement during its hours of operation.
2. Wingos agrees that all entertainment will cease by midnight. It will not have a cover charge for entertainment events or allow dancing.
3. Wingos agrees to contain the sound of the entertainment inside its premises, including keeping its front windows closed during entertainment events.




4. Wingos agrees to provide a contact person and phone number to residents for reporting noise disturbances and further agrees to immediately lower the volume and/or adjust the bass levels.
