# **Police Report**

## Resolution on Zoning Application for Variances at 2405 37th Street NW

At the ANC November meeting, architect Stephen duPont presented the proposal for constructing three new attached structures on the two lots, designed to look like rowhouses, each structure with two "flats," one at the ground level and one above, with underground parking serving all the units. R-3 zoning does not allow "flats." The Commission took public comments on the proposal and will consider a resolution on the application.

# Presentation on Request for Stipulated License for DeCarlo's Restaurant at 4000 Cathedral Avenue

DeCarlo's is hoping to open its new restaurant in coming weeks in the dining space at the Westchester, and the Alcoholic Beverage Regulatory Administration (ABRA) will be opening a comment period on DeCarlo's application for a liquor license at that location. ABRA can issue a "stipulated license" to allow alcoholic beverage service during the comment period. Representatives of DeCarlo's will present the request and take questions. The Commission will vote on a resolution about a stipulated license.
