Its license is currently restricted by a Settlement Agreement with ANC3B that prohibits live music outside, which would need to be amended. An amendment to the Agreement could set conditions on live music performances, such as hours, frequency, and sound levels. The ANC will open a comment period and vote next month on whether or not to amend the Agreement.
