Zoning Variance Request, 3929 Fulton St. The one-family property is being redesigned to accommodate two families, which triggers a zoning issue about parking. Currently there is no onsite parking or driveway. The owners are seeking relief from a requirement to provide at least one parking spot, which would require creating a curb cut for a driveway.

## **Updates And Information**

Elevated Lounge, located at 2428 Wisconsin Ave., 2nd floor, is applying to the Alcoholic Beverage and Cannabis Administration (ABCA) to register as a licensed cannabis retailer. It has operated at this location without incident for the past nearly 3 years as an I-71 dispensary ("gifting" cannabis products to customers who purchase art or other non-cannabis goods). I-71 refers to Initiative 71 which made the use of marijuana legal in the District. The legal sale of cannabis products had been limited to medical use but now general cannabis sales are legal if licensed by ABCA. The ANC will take up this matter at a public meeting when ABCA posts the notice of application.
