**New Business**

The Commission will vote on a resolution regarding emergency rule-making for cannabis regulation. The newly named Alcoholic Beverage and Cannabis Administration (ABCA) is proposing regulations that mirror the alcohol regulations, giving ANC's and communities a say in the location of cannabis facilities. However, the new regulations provide a route for cannabis businesses to have outdoor "safe use" areas, which concern several ANC's throughout the city due to the problem of second-hand smoke. ANC3B will discuss and vote on submitting to ABCA concerns regarding the issue of second-hand marijuana smoke.
