Police Report

Grant application for \$2,500 for food and hygiene supplies for Ward 3 Mutual Aid to deliver to local residents in need. Ward 3 Mutual Aid has been fulfilling requests for food and supplies throughout the COVID-19 emergency, relying on generous donations from residents. No city agencies offer funding for emergency food and other aid to people adversely affected by the pandemic. Leah Ann Brown of Ward 3 Mutual Aid will present the application with representatives of its fiscal sponsor, Open Collective Foundation, a 501(c)3 organization.

Discussion of annual budget for Metropolitan Police District (MPD) and effect on MPD Second District (not before 7:30 pm).
