Discussion of Guy Mason Recreation Center Hours and Maintenance

Christopher Dyer, Community Engagement Manager for DC Department of Parks and Recreation (DPR) and Ralph Wright, Manager of Guy Mason Recreation Center, will participate in the meeting to speak about the hours the rec center is open, maintenance of fields and playground and other facilities, and their work with the Friends of Guy Mason on improvements, and also respond to questions.

Presentation on application for Special Exception for an addition at 2646 39th Street NW

The applicants are asking for zoning approval to construct a rear addition, third story, and penthouse, and add three units to a 4-unit semi-detached building with a cellar in the RA-1 zone. BZA has scheduled a hearing on BZA 20851 on January 11, 2023.

Resolution on Proposed Legislation B24-433 to change RPP parking permits from ward-wide to ANC only Councilmember Mary Cheh held a hearing on the proposal to change the area where Residential Parking Permits apply, so instead of allowing parking for more than two hours in RPP spaces within the entire ward, the RPP would apply only within the new ANC areas that will be in effect January 1, 2023 (and one block beyond the ANC boundary).
