Discussion of new DDOT rules regarding streateries and vote on ANC3B support for an exemption for existing streateries from the rule banning them from streets with rush-hour parking restrictions. ANC support for existing streateries has been requested by Rockland's and Glover Park Main Street.

Special exception zoning request for 3544 W Place. The special exception request is for relief from Zoning Section D-207.4 for a proposed two-story rear addition. D-207.4 states that a rear wall cannot extend more than 10 feet past an adjoining neighbor's residence. The proposed addition would exceed the 10-foot maximum on one side by 4 feet (the proposed addition is 14 feet long and is in compliance with D-207.4 with regard to the other adjoining neighbor's residence).
